

# Message from the Commander



### **Greetings from the Island of Culebra, off Puerto Rico!**

Mercedes and I visit Puerto Rico at least once a year as almost all of her extended family lives in Puerto Rico, mainly in the San Juan metro area. A camping trip was organized by one of her many cousins who has been tent camping at Flamenco Beach for many years. This trip is our third camping trip to Flamenco Beach. The only boat (ship)

experience was the ferry going and coming to Culebra from the main island of Puerto Rico. The ferry now leaves from the former U.S. Navy base of Roosevelt Roads. The closest town to the ferry is Ceiba (approximately 8 miles away), which is approximately 40 miles east of San Juan and is directly on the water. The ferry passage is approximately 23 miles (2 hours) each way was a little "lumpy", but not bad considering it is almost entirely in unprotected waters of

the Atlantic Ocean. The ferry is fairly small as ferries go -- it holds only approximately 12 to 15 cars (less if there are trucks) and approximately one hundred passengers. Many people

go for just the day. The ferry docks at Dewey, the only town on Culebra. There is a fairly inexpensive taxi service to Flamenco Beach from Dewey and back during the day light hours. I hope you all can visit this beautiful place as well someday.



From the Beltway Driving South: Drive south on I-95 from the Beltway and take the exit for Woodbridge via US Rt. 1 south. Turn left at Furnace Road, which is at the first traffic light. This is just prior to the Occoquan River Bridge. Follow Furnace Road through the railroad underpass (Caution one car wide and a blind turn, sound your horn before entering). Continue about another 75 -100 yards where Furnace Road bears to the left and joins Old Colchester Road. Do not bear to the left but proceed straight across. This is a private lane, which leads into the Fairfax Yacht Club. Follow this lane through the gate (it will be open) and park at any open space.

The **Jones Point Light** is a small river <u>lighthouse</u> located on the <u>Potomac River</u> in <u>Alexandria, Virginia</u>. It was built in 1855. It is a small, one-story house with a lantern on top and served primarily as a warning light for naval ships approaching the <u>Washington Navy Yard</u>. The lighthouse was discontinued in 1926, replaced by a small steel <u>skeletal tower</u> located nearby; this smaller tower was in use for ten years before being discontinued. After being dark for more than half a century, Jones Point Light was relit by a private concern in 1995, however, it was eventually put out again after ownership switched from the <u>Daughters of the American Revolution</u> Foundation to the <u>National Park Service</u>.

The lighthouse is located on <u>Jones Point</u> in Alexandria, and is part of <u>Jones Point Park</u>. Visitors can approach the lighthouse, but it is currently impossible to enter the building. In 1980, the lighthouse and the cornerstone were listed in the <u>National Register of Historic Places</u> as reference #80000352. The lighthouse is also listed in the <u>Library of Congress Historic American Buildings Survey</u> as survey number VA-641. # Get Certified as a Vessel Safety Check Examiner Study Manual is Available Online

Message from Chair P/C Rich Unis, JN

The VSC program is a very important ongoing public service effort sponsored by the United States Coast Guard Auxiliary, the United States Power Squadrons and BoatUS.

Qualified Vessel Examiners (VEs) from both organizations provide courtesy safety checks to mariners to ensure required safety

equipment is aboard and in operational condition.

- The VEs discuss safe boating practices while conducting their reviews to ensure boaters are well informed of their responsibilities.
- VEs award the VSC decal to boat owners whose vessels meet the minimum safety requirements.
- If you would like to become a VE, you will need to study
  the VSC manual and take a quick certification exam, both
  which can be completed online, then conduct five VSCs in
  the presence of a qualified VE before becoming certified
  and able to conduct them on your own.



## Virginia Boating Safety Education Requirement


All PWC operators age 14 and older and all operators (regardless of age) of motorboats with a 10 hp or greater engine need to take a boating safety course.




